Thus working in line with the guidance made by 'Working Together to Safeguard Children, 1999'.

♦ To discuss national and local reports, including results of Part 8 and management reviews from the Area Child Protection Committee (ACPC) and the implications of the recommendations from these upon practice and policy, to then further disseminate information and adjust policies accordingly.

- ◆ To discuss issues, difficulties and perceived deficiencies around child protection practice, particularly those which occur across agencies.
- ♦ To inform the ACPC via the local Area Monitoring Group (AMG) or designated child protection professionals the agreed difficulties relating to multi-agency practice and working together, also to receive and review information collected from these sources.
- ◆ To take forward the recommendations for standards of care for children and their families within the hospital setting made by the National Service Framework for Children-Standard for Hospital Service (2003), particularly those related to child protection and children in need.
- ♦ To regularly review and audit child protection practice and policy, and continue to proactively progress the recommendations made by Lord Laming following the Climbié Inquiry and recommendations made by the CHI audit conducted within the Trust.
- ♦ To make recommendations for issues to be included in child protection training and staff groups to be targeted for different levels of training.

The Terms of Reference will be reviewed 6 monthly.
